## Advertisement

Applications are invited in the prescribed proforma (Annexure-A, given) from eligible Officers for filling up following posts in Sashastra Seema Bal on deputation/re-employment basis, as per eligibility criteria given below:-

### 1. Post, Pay Scale and Number of Post: Post:- Inspector General (Works)

**Pay Scale:-** Level-14 in the Pay Matrix.

**Vacancy at:-** FHQ, SSB, New Delhi

**Eligibility Criteria: Deputation:-** Deputation of officers of the Indian Police Service holding or empanelled to hold the post of Inspector General of Police in the Central Government and also possessing Bachelors Degree in Civil Engineering, or

Officers of the Central Government or the State Government or Central Armed Police Forces including Sashastra Seema Bal or Central or State Public Works Departments or Military Engineering Services or General Reserve Engineering Force.

(a) (i) holding analogous posts on regular basis in the parent cadre; or

(ii) with two years' regular service in the Level -13-क in the pay matrix; and

(b) (i) possessing Bachelor's Degree in Civil Engineering from a recognized University; and

(ii) fifteen years' experience in execution of civil works.

(i) Should possess Degree in Telecommunication Engineering or Electrical Communication Engineering or Electronics from a recognized University or Institute or Associate Member of the Institution of Electronics and Telecommunication Engineer or Associate Member of the Institution of Engineers or equivalent or M.Sc. in electronics or Telecommunication or Information Technology or Computer Science or equivalent from a recognized University or All India Council for Technical Education approved Institution; and

**Eligibility Criteria: Deputation/Absorption:-** Officers of the Central Government or the State Government or Central Armed Police Forces including Sashastra Seema Bal or Central or State Public Works Departments of Military Engineering Services or General Reserve Engineering Force.

(a) (i) holding analogous posts on regular basis in the parent cadre; or

(ii) with five years regular service in the Level-10 in the pay matrix; and

(b) (i) possessing Bachelor's Degree in Civil Engineering from a recognized University; and

(ii) five years experience in execution of civil works.
